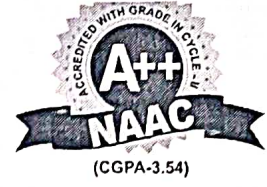

**Note:** Shop No. 2 will also be allotted to a single vendor for the amenities of Photocopy and Stationary items and Retail Medical Shop. The minimum eligibility criteria for allotment of Shop No. 2 are as under:

- The sale of medicines should be made in the presence of a registered pharmacist during working hours for which proof of a pharmacist with name, Registration with the State Council etc. be submitted along with bid.
- It shall be the responsibility of the applicant to obtain drug license to run the medical shop in the University campus and other permissions. Compliance to all statutory requirements for storage of drugs shall be ensured by the applicant only.

Further, the date of receipt of the tender has now been extended till **10.11.2023 upto 2.00 PM**. The Technical bids received against the tender, will be opened on the same day. All other terms & conditions will remain same as per original tender document.
