## Guidelines for processing the admission of International students at Central University of Rajasthan for AY 2024-25

- Central University of Rajasthan is participating in the admission of International students for AY 2024-25 through Study in India portal.
- The university has registered at the portal and started receiving application forms for admission in various courses from different countries.
- The processing of applications including checking the eligibility criteria, documents, etc. need to be initiated in order to confirm the admission and sending the offer letter. A committee could be proposed for the same.
- Minimum eligibility qualifications for international students will be the same as for
- Indian students for each program mentioned in the University Prospectus. For more details, please visit University website <a href="http://www.curaj.ac.in">http://www.curaj.ac.in</a>.
- The program on which eligibility is to be relied upon must be from an Institute included in the list of the Association of Indian Universities (AIU). AIU House, 16 Comrade Indra Jit Gupta Marg (Kotla Marg), Landmark: Opposite National Bal Bhawan, Near I.T.O., New Delhi110002, INDIA (https://www.aiu.ac.in/).

In case the University/Board is not included in the said list, the candidate has to obtain and submit an Equivalence Certificate to this effect from the Association of Indian Universities.

English translations of all transcripts, duly attested, are to be submitted.

Candidates applying from their own country should get their transcripts attested by the concerned accredited authorized government agency and also duly certified by the Indian Embassy or Consulate.

- The proposed committee members will along with checking the fulfillment of required eligibility could schedule an online interaction meeting with the applicants prior to admission.
- Such interactions could be scheduled every fortnight or as per the number of applications received.
- Following the above-mentioned process, an offer letter will be uploaded at Study in India portal.
- The candidates could be given a particular time period to reserve their seat for admission in a particular program by depositing 10% amount of the fees.
- On being granted admission, all applicants should produce their Students Visa within one month of completion of admission formalities. In case of failure to obtain a visa within the stipulated period, the admission shall stand cancelled. A copy of this visa is to be submitted in the Office of International Affairs, First Floor, Central University of Rajasthan, Bandarsindri, Kishangarh, Ajmer305817, Rajasthan, India.
- Upon arrival in India every foreign student must register with the Foreigners Regional Registration Officer (FRRO) (<a href="https://indianfrro.gov.in/eservices/home.jsp">https://indianfrro.gov.in/eservices/home.jsp</a>). The university will be happy to facilitate your application at any point of time.

At the time of admission students should have valid Residential permit in India granted for studies/ Student Visa/ Research Visa for the prescribed duration of the Concerned Course.
