**NOTICE INVITING QUOTATIONS**

Quotations are invited from reputed firms for "Servicing and maintenance of Defunct Reverse Osmosis Water Systems" of B1, B2, B3, B4 & B7 Hostels (05 nos.) in the University by the Registrar, Central University of Rajasthan, Bandar Sindri, Kishangarh (Ajmer). *Duly filled, signed and sealed quotations shall be submitted in Room No. 101, Ground Floor Administration Building, Central University of Rajasthan or may also be submitted electronically through e-mail: [estate@curaj.ac.in](mailto:estate@curaj.ac.in) under the terms and conditions detailed below on or before 25.05.2025 till 2:00 P.M. Quotations other than the prescribed pro-forma as downloaded (Annexure) from the University website shall be summarily rejected.*

**1. Servicing Terms and Conditions:**

The Bidder must inspect all the defunct RO plants for hostels mentioned above and should prepare a report of the faults and spares to be replaced in each R.O. plant in the format as Annexure provided and must enclose along with the quotation:

- 1.1 The bidder must indicate the warranty period of the spares which are need to be replaced.
- 1.2 The old defective parts must be handed over to the University.
- 1.3 The rates quoted by the Bidder shall be inclusive of GST and all charges. The Bidder shall be solely responsible for installation and safe delivery of goods in good condition.
- 1.4 During the warranty period, it is the responsibility of the Bidder to rectify/replace the faulty spares with new ones which are found to be defective.
- 1.5 Losses incurred due to mishandling/ misplacement/ theft or any malpractice by technicians during the period of servicing, has to / make good of the losses suffered by the University due to fault. In case of non-reimbursement/ making good by the Bidder, the same shall be recovered from the bills by the University.
- 1.6 No advance payment will be made under any circumstances.

**2. Validity of the Quotations:**

- 2.1 The rates once quoted and approved shall be final and valid for one year from the date of opening of quotations and no deviation will be accepted in enhancement of rates by the Bidder.
- 2.2 The quotations received either by post or in person after the due date and time shall be summarily rejected.
- 2.3 All rights reserved to the University to accept or reject the quotations. Decision of the University authorities will be final in all matters.
