1. The Law Officer shall be eligible for consolidated monthly salary of Rs. 60000/- per month only.
2. The candidate will not be entitled to any other benefits, which are admissible to the regular employees of the Central University of Rajasthan.
3. This engagement will not vest any right to claim for regular appointment in the University or for continued services in the University.
4. Candidates are advised to ensure/satisfy themselves that they fulfill all the eligibility criteria. It is the responsibility of the candidate to assess his/her eligibility for the post for which he/she is applying.
5. The University reserves the right to terminate this engagement any time even before the stipulated period in case of unsatisfactory performance, misconduct or any other administrative reasons / compulsions.
