For Appointment of PSU/Govt. Organization under purview of Rule 133(3) of the GFR 2017 as Project Management Consultant for Construction of 10-Bedded Primary Health Centre (PHC) at CURAJ Campus.

The Central University of Rajasthan (CURAJ) proposes to establish a 10-bedded Primary Health Centre (PHC) within its campus to cater to the healthcare needs of students, faculty, staff, and residents. The University invites Expression of Interest (EOI) from eligible and reputed Public Sector Undertakings (PSUs) engaged in architectural, engineering, and project management consultancy services.

Scope of Work

The selected PSU/Govt. Organization consultancy agency shall provide end-to-end consultancy services, including:

1. Conceptual Planning & Architectural Design
2. Structural Design as per NBC & seismic norms

3. Design of Electrical, Plumbing, HVAC, Fire Safety & Medical Gas Systems
4. Preparation of Detailed Project Report (DPR)
5. Preparation of Detailed Estimate & Bill of Quantities (BoQ)
6. Drafting of Tender Documents (Technical & Financial)
7. Assistance in Tender Process , Technical and financial Evaluation
8. Supervision, Monitoring & Quality Assurance during Construction
9. Verification of Contractor's Bills and Certification
10. Issuance of Project Completion & Compliance Certificate
11. Any other as per need of the project.

Eligibility Criteria

- The applicant agency must be a Government of India Public Sector Undertaking (PSU) / CPSUs / SPSUs / State Govt. with relevant experience.
- Must have successfully executed at least one hospital/healthcare or institutional infrastructure project of similar nature.
- Must have competent in-house/empanelled experts including Architects, Civil/Structural Engineers, MEP Experts, Quantity Surveyors, and Project Supervisors.
- Must be willing to work on percentage fee basis linked to **estimated cost / tendered cost / work completion cost, whichever is lower.**

- Shortlisted PSU/Govt. may be invited for presentation/discussion.
