	Considering the stature and to give appropriate recognition to the Padma awardees, it is proposed to enhance the cash prize to Rs. 51,000/- with a shawl, Bhagwat Geeta, Shree-fal and a Memento, from the 17 <sup>th</sup> Foundation Day.			
	Resolution: The Executive Council well appreciated such initiatives taken by the University and approved the proposal of conferring the Life Time Achievement Award to the Padma Awardees with the with a cash prize to Rs. 51,000/- shawl, Bhagwat Geeta, Shreefal and a Memento.			
54-4.6	The matter relating to Pay Protection of newly appointed teaching staff			
	It was brought to the notice of the members that the Executive Council, in its 52nd meet- ing held on 18.07.2024 (relevant extract of Agenda Item No. 52-4.6 attached as <b>Annex- ure-D</b> ), resolved that the probation period for faculty members appointed henceforth shall be extended from one year to two years. It was further resolved that all consequen- tial benefits would be provided only after the successful completion of the two-year pro- bation period.			
	The members were apprised that as per the DoPT norms, pay protection is available to direct recruits who fulfill the prescribed eligibility criteria. To align with these norms and to attract and retain quality faculty, it is proposed that the benefit of pay protection be made available to the newly appointed regular teaching staff as per their eligibility.			
	In view of the above, the earlier resolution regarding the probation period may be amended and revised as follows:			
	"The probation period for faculty members appointed henceforth shall be extended from one year to two years. All consequential benefits, including addition of past services, senior- ity, and other admissible benefits as per UGC Regulations, 2018 (as amended from time to time), shall be provided from the date of joining, but only after the successful completion of the two-year probation period. Appointment letters may be corrected/ revised accordingly, and relevant ordinances modified to this extent."			
	Resolution: The Executive Council approved the amendment regarding probation period by continuing the benefit of pay protection to newly appointed regular teaching staff as per their eligibility.
